This legislation, administered by the U.S. Department of Education (ED), authorizes the federal government s major student aid programs, as well as other significant initiatives. Legislative action on the reauthorization has begun. On July 9, 2003, the House passed the first in a series of bills which Committee members plan to move to reauthorize the HEA. The first legislation approved addresses HEA provisions related to preparation of K-12 teachers. On September 25, 2003, the House Education and the Workforce Committee approved separate bills amending and reauthorizing the international education and graduate support titles of the HEA. Postsecondary education is a complex, decentralized enterprise, made up of a wide array of institutions enrolling a large and diverse student body. In academic year 20002001, approximately 6,600 degree- and nondegree-granting postsecondary education institutions were eligible to participate in the HEA s student aid programs. These institutions enrolled an estimated 15.9 million students in the fall of 2000. HEA programs and activities fall primarily into four main categories:
